Your Account is eligible for an interest rate and annual percentage yield (APY) based on the activity in the Account during each statement cycle. If you meet the "Qualifications" (as explained below) during a statement cycle, your Account will earn a premium interest rate.

| Effect of Closing an <br> Account | If you close your account before interest is credited, you will not receive the accrued interest. |
| Balance Computation <br> Method | We use the daily balance method to calculate the interest on your account. This method applies a daily periodic <br> rate to the principal in the account each day. |
| Accrual of Interest on <br> Noncash Deposits | Interest begins to accrue no later than the business day we receive credit for the deposit of noncash items (for <br> example, checks). |
| Deposit Limitations: | You may make unlimited deposits into your account. <br> Account FeesThere is no fee for eStatements or paper statements. There are no Foreign ATM fees when using an ATM that is <br> a member of the Alliance One or AllPoint Network. When you use an ATM not owned by us, you may be <br> charged a fee by the ATM operator or any network used. | Qualifications to Receive <br> the Direct Interest Rate: | To receive the direct interest rate on this account during a statement cycle, you must have one (1) or more Direct <br> Deposit(s). |

Subject to applicable law, we will charge a <br> dormant fee. The account will be presumed to be abandoned and will be remitted to the custody of the applicable <br> state agency.
