### **Review Your Mortgage Rate**

As March arrives, we are getting close to the end of the first quarter of 2020. This is a great time to reflect on mortgage interest rates and see how rates stack up to the years past. In 2015 and 2016 rates dropped to an historical low. In January of 2015 the 30-year rate was sitting at 3.75% compared to 4.50% the previous January. Buying or refinancing was a high priority at that time. Rates continued to fall in 2016, and by July rates had settled at 3.25% for a 30-year mortgage. After staying at 3.25% for several months, rates rose to 4.25% by the end of 2018. 2019 saw rates retreat to 3.625%, continuing to fall gradually to the current 3.125%. Whether you want a rate and term refinance or maybe a cash out to do home improvements, add a swimming pool, or detached garage now is great time to review your current rate and see how much you can save not just monthly but in the long run compared to your

Prior to joining Springs Valley Bank & Trust, he worked for 14 years at First Federal Savings Bank in Huntington, IN as Senior Vice President and CFO and for 3 years at Tower Financial Bank as Vice President and Controller. In his 15 years at Springs Valley, he has overseen the Finance and Accounting Departments and
