But the difference you'll feel, is "relationship driven"

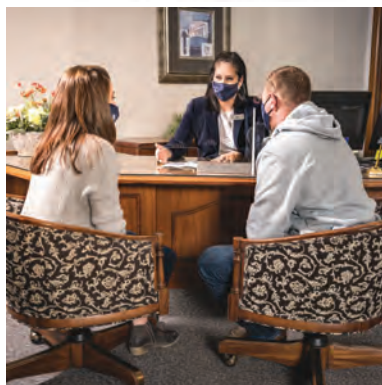
