Read below some highlights of Springs Valley digital banking tools that are safe, easy, and ready to use.

MOBILE WALLET

Mobile Wallet provides great benefits to your Springs Valley Visa card with Google Pay, Apple Pay, and Samsung Pay. With a quick tap of your smartphone or watch, you can use your Springs Valley Visa Card to pay at stores that accept mobile payments. To use, simply unlock your phone and hold it up to the card reader at participating retailers. When you use Mobile Wallet, your card is replaced by a unique code for each transaction – adding an extra layer of security!

MOBILE DEPOSIT

Mobile Deposit allows you to use your mobile phone to deposit checks. All you have to do is snap a picture of the front and back of your check using your Springs Valley Mobile Banking App. This saves time and requires fewer trips to the ATM or Bank.

CREDIT SENSE

Credit Sense is a convenient credit score service. If you have a Springs Valley Credit Card, all you have to do is log into your Springs Valley Mobile App. Credit sense provides instant access to your credit score. It also provides credit reporting, monitoring, and alerts are available. Credit Sense also provides educational tools to assist you in developing a better credit score and managing credit.

BILL PAY

Online Bill Pay eliminates the hassle of postage and check writing. Bill Pay offers unlimited bill pay transactions, the ability to create reoccurring and on-demand payments, and the ability to import information into accounting systems. It is a safe, fast, and convenient way to manage money.

eSTATEMENTS

eStatements are an electronic version of your monthly paper statement that can be delivered to your eMail inbox rather

than through the postal service. They are identical to paper statements and contain the same information, but they are electronic! eStatements arrive sooner than paper statements and are beneficial to the environment. eStatements are free and available to you 24 hours a day, seven days a week.
