Beneficial Ownership Information



How Do I Report? Reporting companies will have to report beneficial ownership information electronically through FinCEN's website: www.fincen.gov/boi

In 2021, Congress enacted the Corporate Transparency Act. This law creates a beneficial ownership information reporting requirement as part of the U.S. government's efforts to make it harder for bad actors to hide or benefit from ill-gotten gains through shell companies or other opaque ownership structures.

New Federal Reporting Requirement

Beginning on January 1, 2024, many companies in the United States will have to report information about their beneficial owners, i.e., the individuals who ultimately own or control the company. They will have to report the information to the Financial Crimes Enforcement Network (FinCEN). FinCEN is a bureau of the U.S. Department of the Treasury.
