Official Terms and Conditions

Springs Valley Bank & Trust Company (“**Sponsor**”) is sponsoring “Spot the Pig, Snag a Prize” (the “**Giveaway**”) Unless specifically noted otherwise by Sponsor, these terms and conditions shall serve as the “**Official Rules**” for the Giveaway. The terms “**you,**” “**your,**” and “**participant(s),**” all refer to the person entering and/or participating in the Giveaway.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. GIVEAWAY IS VALID ONLY IN THE STATE OF INDIANA, UNITED STATES; VOID WHERE PROHIBITED.

1. GIVEAWAY DATES: The Giveaway will begin at 2 PM (EST) on April 7th, 2026 and end at 11:59 PM (EST) on May 1st, 2026 (“**Giveaway Period**”). The Sponsor’s clock will be the official timekeeper for the Giveaway.

2. SPONSOR AND PROMOTER: Springs Valley Bank & Trust Company, 1500 Main Street, Jasper, Indiana 47546 is the sponsor and promoter of the promotion. The Sponsor may terminate, extend, suspend or alter the Giveaway at any time in its sole discretion.

3. ELIGIBILITY: This Promotion is open only to legal U.S. residents who are eighteen (18) years of age or older and reside in the State of Indiana as of date of entry. Employees of Sponsor, its parent company, and any affiliate of either, and members of the immediate family of such persons, are not eligible to participate in the Promotion. For purposes of the Promotion, the term “immediate family” includes a person’s spouse, parents and grandparents, children and grandchildren, brothers and sisters, mother in law and father in law, brothers in law and sisters in law, daughters in law and sons in law, and those persons living in the same household of such persons. HOW TO ENTER: During the Giveaway Period, participants who locate an SVBT Piggy Bank will bring the piggy bank to the corresponding Springs Valley Banking Center listed on the prize voucher within the piggy bank. The prize and identification code listed on the voucher will designate your prize. The SVBT Piggy Banks will be placed in locations and at times within the giveaway period at the sole discretion of Sponsor.

Your submission may not contain, depict or reference any names, materials, products, or services of any company or entity (other than the Sponsor), including, without limitation, any third party trademarks, logos, or trade dress. Your submission may not promote any product or service other than those of the Sponsor. Any clothing, signs, images of food products or other images visible in the selfie submitted should not contain any visible third party logos, drawings, cartoons, phrases, or trademarks.

Your submission may not in any way violate or infringe the copyright, trademark, privacy, publicity, or other personal or proprietary rights of any person or entity. Your submission may not contain look-alikes of celebrities or other public figures, living or deceased.

Your submission may not, as determined by Sponsor in Sponsor's sole discretion include, contain, depict, or discuss: (i) any illegal, immoral, obscene, profane, lewd, inappropriate, disparaging, libelous, defamatory, or offensive material; (ii) any content unsuitable for broadcast, publishing, posting or reproducing (including, but not limited to, nudity, pornography, profanity, or the incorporation of drugs or alcohol); (iii) any racial, ethnic, religious, or sexual derogatory characterizations or slurs; (iv) any threats to any person, place, business, group or world peace; or (v) any material that features, suggests and/or promotes violence or dangerous activities that may result in injury to yourself or others, and your selfie must not have been dangerous or unsafe to make.

Your submission must not violate any laws, regulations, or applicable Facebook and Twitter posting standards.

5. LIMIT AND ENTRY FREQUENCY: Participants may only bring in 1 (one) piggy bank during the Promotion Period. Participants do not have to be a Springs Valley Bank & Trust customer.

6. WINNER SELECTION & NOTIFICATION: Unless otherwise specified in the Giveaway, twenty (20) winners will be determined by the piggy banks and vouchers turned into the corresponding banking centers. Prize winners will be notified upon receipt of the piggy bank. All piggy banks brought in later than May 30th, 2026 will not be eligible for a prize.

Photo/Video entries will be drawn on May 14, 2026 at 9:00 a.m. EST. In the event that the Winner is disqualified for any reason, the Sponsor will award the Prize to an alternative winner as determined by a random draw from the remaining eligible entries and such person shall be deemed the Winner. (b) The decisions of the Administrator and/or Sponsor as to the administration and operation of the Promotion and the selection of the potential winners are final and binding in all matters related to the Promotion.
